RESOLUTION REQUESTING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) TO AUTHORIZE THE MUNICIPAL GOVERNMENT OF NARVACAN, ILOCOS SUR TO LEASE THE FORESHORE AREAS OF THE COASTAL BARANGAYS OF THE MUNICIPALITY FOR THE PURPOSES SPECIFIED HEREIN
