**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR EDGARDO D. ZARAGOZA TO ENTER INTO A LEASE AGREEMENT WITH THE STALLHOLDERS OF THE NARVACAN COMMERCIAL COMPLEX (PUBLIC MARKET II) FOR THE PURPOSE SPECIFIED HEREIN**

**WHEREAS**, the stalls at the Narvacan Commercial Complex (Public Market II) shall be open for lease by interested stallholders-applicants;

**WHEREAS**, to prevent misunderstanding of the terms and conditions of lease holding, this Resolution requires all stallholders of the Narvacan Commercial Complex (Public Market II) to enter into a written contract with the Municipality of Narvacan;

**WHEREAS**, this Resolution authorizes Mayor Edgardo D. Zaragoza to represent the Municipality of Narvacan, enter into a Lease Contract Agreement with the stallholders of the Narvacan Commercial Complex (Public Market II) and shall be referred to as the LESSOR in the Contract of Lease.

**WHEREAS**, the Contract of Lease Agreement shall take effect upon approval of the LESSOR and the LESSEE and shall be effective for the period as stated in the Lease Contract and may be renewable upon mutual agreement of both parties, unless earlier revoked or cancelled by the Sangguniang Bayan for a cause;

**WHEREAS**, the Contract of Lease shall stipulate among others that both LESSOR and LESSEE shall strictly comply with the terms and conditions of the Lease Contract Agreement;

**NOW THEREFORE**, on motion duly seconded by the body, BE IT RESOLVED AS IT IS HEREBY RESOLVED to authorize Mayor Edgardo D. Zaragoza of the Municipality of Narvacan to enter into a Lease Agreement with the stallholders of the Narvacan Commercial Complex (Public Market II) for the purpose specified herein;






