RESOLUTION AUTHORIZING MR. TERESITO C. VALERA, SR., MUNICIPAL COUNCILOR, TO ATTEND THE 16TH ANNIVERSARY CELEBRATION OF THE SISTERHOOD PACT BETWEEN THE CITY OF GROVER BEACH, CALIFORNIA AND THE MUNICIPALITY OF NARVACAN, ILOCOS SUR, PHILIPPINES ON SEPTEMBER 29, 2007.

WHEREAS, the Municipality of Narvacan has an existing sisterhood ties with Grover City, California, which was formally forged in October 1991;

Congressman of the 22nd Federal District of California, Lois Capps, have extended their invitation to the Municipal Officials of Narvacan, Ilocos Sur to attend the anniversary celebration on 29 September 2007 in Grover City;

WHEREAS, Councilor Teresito C. Valera, Sr., has been invited to the celebration;

WHEREAS, the Municipality of Narvacan shall shoulder the air fare and all other expenses of Councilor Teresito C. Valera, Sr. in attending the aforementioned sisterhood anniversary celebration;
