**RESOLUTION EARNESTLY REQUESTING THE HON. ERIC D. SINGSON, REPRESENTATIVE, 2<sup>ND</sup> DISTRICT OF ILOCOS SUR, FOR HIS FINANCIAL ASSISTANCE AMOUNTING TO THREE MILLION PESOS (P3,000,000.00) FOR THE CONSTRUCTION OF A BASKETBALL COVERED COURT AND IMPROVEMENT OF THE MUNICIPAL KIOSK AT NARVACAN, ILOCOS SUR**

**WHEREAS**, one of the development priorities of the Municipal Administration is the infrastructure and rehabilitation program which also focuses on the improvement of various old structures and projects within the municipality;

**WHEREAS**, this goal, however, is constrained by financial limitation as the municipal administration depends on project grants given by the national government, the senators, congressmen, and provincial officials who are supportive to our development efforts;

**WHEREAS**, the construction of a basketball covered court and improvement of the Municipal Kiosk will eventually serve as a fitting venue wherein to conduct significant activities, programs and gatherings especially during the celebration of the annual town fiesta of the municipality;

**WHEREAS**, the members of the Municipal Council are cognizant of the need to provide the people better and secured place to conduct such important activities especially during rainy season;


**WHEREAS**, the construction of a basketball covered court and the improvement of the Municipal Kiosk will serve as an income-generating establishment where big events of the municipality will be staged;

**NOW THEREFORE**, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to request the **Hon. Eric D. Singson**, Representative, 2<sup>nd</sup> District of Ilocos Sur, for his financial assistance amounting to three million pesos (P3,000,000.00) for the construction of a basketball covered court and improvement of the Municipal Kiosk at Narvacan, Ilocos Sur;


**RESOLVED FURTHER** that a copy of this Resolution be forwarded to the **Hon. Eric D. Singson** for his kind information and appropriate action.
