**A RESOLUTION ADOPTING, APPROVING AND CONCURRING WITH THE MUNICIPAL COASTAL RESOURCE MANAGEMENT FRAMEWORK PLAN OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR**

**WHEREAS**, indorsed to the Sangguniang Bayan of the Municipality of Narvacan, Ilocos Sur for legislative approval was the Municipal Coastal Resource Management Framework Plan prepared by this municipality in close coordination with several sectors and agencies;

**WHEREAS**, the plan is in answer to the need to protect, conserve and replenish the resources of our coastal areas in the face of widespread coastal and environmental degradation resulting in the alarming rate of depletion of our marine resources;

**WHEREAS**, the effective development and management of our coastal area ecosystem and its resources was started by Hon. Luis "Chavit" Singson, Governor, Province of Ilocos Sur, in his capacity as chairman of the Regional Development Council, Region I;

**WHEREAS**, balanced and discreet, sustainable development as envisioned in the Municipal Coastal Resource Management Framework Plan is a globally advocated step towards economic development, a kind that would at the same time ensure the protection and integrity of the environment;

**WHEREAS**, the adoption of the Municipal Coastal Resource Management Framework Plan shall guarantee a wise and responsible use of our marine and coastal resources to insure that they shall ever be there to sustain our economic need and that of future generations;

**NOW THEREFORE**, the Sangguniang Bayan of Narvacan, Ilocos Sur, in regular session duly assembled, **RESOLVED, AS IT IS HEREBY RESOLVED**, to adopt, approve and concur with the Municipal Coastal Resource Management Framework Plan of this municipality to be implemented in the next ten years.






