**RESOLUTION REQUESTING THE HON. ERIC D. SINGSON, REPRESENTATIVE, 2<sup>ND</sup> DISTRICT OF ILOCOS SUR, TO FILE A HOUSE BILL CONVERTING THE MUNICIPALITY OF NARVACAN, ILOCOS SUR INTO A COMPONENT CITY, IN THE HOUSE OF REPRESENTATIVES**

**WHEREAS**, the conversion of Narvacan into a component city will greatly benefit the local government unit for it would be entitled to a bigger share in the Internal Revenue Allotment (IRA);

**WHEREAS**, a greater IRA share means an additional fund which could be used to pursue more development projects and deliver more basic services and facilities to the people;

**WHEREAS**, Narvacan is a bustling town of commerce and industry as manifested by the soon-to-be constructed 2-storey Commercial Complex in a sprawling 5.5209 hectate of land at Brgy. Margaay, Narvacan;

**WHEREAS**, Narvacan has already satisfied the minimum requirements for the conversion into a component city under Section 450 of RA 7160, otherwise known as the Local Government Code of 1991 such as: land area and yearly income;

**NOW THEREFORE**, the Sangguniang Bayan of Narvacan, Ilocos Sur, in regular session duly assembled,

**RESOLVED, AS IT IS HEREBY RESOLVED**, to request the Hon. Eric D. Singson, Representative, 2<sup>nd</sup> District of Ilocos Sur, to file a house bill converting the Municipality of Narvacan into a component city, in the House of Representatives;

**RESOLVED FURTHER AND FINALLY** that a copy of this Resolution be forwarded to the Hon. Cong. Eric D. Singson, 2<sup>nd</sup> District of Ilocos Sur, for his information and favorable action.
