RESOLUTION ALLOCATING FUNDS FOR MUNICIPAL DEVELOPMENT PROJECTS IN THE AMOUNT OF ONE MILLION SEVEN HUNDRED SEVENTY FIVE THOUSAND NINETY SEVEN PESOS (P 1,775,097.00) REPRESENTING THE DIRECT SHARE OF THE MUNICIPALITY OF NARVACAN FROM THE TOBACCO EXCISE TAX PURSUANT TO RA 7171 FOR THE CALENDAR YEAR 2007




