WHEREAS, the Municipality of Narvacan, Ilocos Sur is saddened with the initial reports that the unsolved killings in the municipality was apparently committed by some PNP personnel in the locality;

WHEREAS, these suspected PNP Personnel has masterminded the killings of individuals through the service of the "gun for hire" operatives;

WHEREAS, it is discouraging to note that the unsolved killings of innocent individuals including a balikbayan has threatened the peace and order situation of the municipality and has also affected our Balik sa Bayan Program;

WHEREAS, the apparent involvement of some PNP personnel in such brutal killings will surely lessen the trust and confidence of the people to our PNP force;

WHEREAS, one effective measure to stop this inhumane acts is to seek the higher headquarters of the PNP to help us in the investigation of these unsolved killings;

WHEREAS, only a very strong and determined police enforcement and thorough investigations will lead us to the capture of the perpetrators and it will lead Narvacan from the bandits of social crimes;

NOW THEREFORE on motion of Councilor Carlito T. Corrales, duly seconded, BE IT RESOLVED AS IT IS HEREBY RESOLVED to request the PHILIPPINE NATIONAL POLICE TO HELP US IN THE INVESTIGATION OF UNSOLVED KILLINGS IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR APPARENTLY COMMITTED BY SOME PNP PERSONNEL IN THE LOCALITY.

**RESOLVED FURTHER** that copies of this resolution be forwarded to the PNP Chief, Director General Oscar Calderon and PNP Regional Director, Police Chief Superintendent Leopoldo Bataoil for their information and appropriate action.
