RESOLUTION ALLOCATING FUNDS FOR MUNICIPAL DEVELOPMENT PROJECTS IN THE AMOUNT OF TWENTY SEVEN MILLION SIX HUNDRED FIFTY ONE THOUSAND EIGHT HUNDRED NINETY PESOS (PhP 27,651,890.00) REPRESENTING THE SECOND RELEASE OF THE DIRECT SHARE OF THE MUNICIPALITY OF NARVACAN FROM THE TOBACCO EXCISE TAX PURSUANT TO REPUBLIC ACT 7171 FOR THE CALENDAR YEAR 2011


RESOLVED FURTHER to enact the corresponding appropriation ordinance, to wit:
