RESOLUTION ALLOCATING FUNDS FOR MUNICIPAL DEVELOPMENT PROJECTS IN THE AMOUNT OF TWENTY SEVEN MILLION SIX HUNDRED FIFTY ONE THOUSAND EIGHT HUNDRED NINETY PESOS (PhP 27,651,890.00) REPRESENTING THE DIRECT SHARE OF THE MUNICIPALITY OF NARVACAN FROM THE TOBACCO EXCISE TAX PURSUANT TO REPUBLIC ACT 7171 FOR THE CALENDAR YEAR 2011

WHEREAS, the Municipal Administration has identified priority projects to sustain its development efforts thereby strengthening the economy of the municipality;

WHEREAS, the Members of the Sangguniang Bayan fully support the development agenda of the Municipal Administration;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to appropriate the amount of Twenty Seven Million Six Hundred Fifty One Thousand Eight Hundred Ninety Pesos (PhP 27,651,890.00) representing the direct share of the Municipality of Narvacan from the tobacco excise tax pursuant to Republic Act 7171 for the calendar year 2011;


RESOLVED FURTHER to enact the corresponding appropriation ordinance, to wit:






