RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL STATISTICS OFFICE (NSO) FOR THE PURPOSE SPECIFIED HEREIN

WHEREAS, the National Statistics Office (NSO) has developed an updated software, the Philippine Civil Registry Information System (PhilCRIS) to deliver civil registry information management in a new, more user friendly and efficient way;

WHEREAS, the PhilCRIS is a software in Windows version of the Civil Registry Information System (CRIS DOS version) which enables encoding of relevant information from civil registry documents, storage of vital data, query and retrieval of encoded records, printing and issuance of certified copies of encoded civil registry documents, generation of transmittal files, data management and maintenance of the local civil registry database;

WHEREAS, the use of PhilCRIS will enable the receiving institution to preview and print directly to the new civil registry forms;

WHEREAS, this Resolution authorizes **Mayor Zuriel S. Zaragoza** to enter into a Memorandum of Agreement with the NSO which stipulates that the Local Government Unit of Narvacan is given authorization to use the PhilCRIS free-of-charge in accordance with the rules and regulations set out for its purpose;


WHEREAS, the said MOA stipulates also that the NSO shall provide the complete set of parameters, the user manual and softcopy of the user forms, technical support, and revisions and/or upgrading of the PhilCRIS software;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the **Municipal Mayor Zuriel S. Zaragoza** to enter into a memorandum of agreement with the National Statistics Office (NSO) for the purpose specified herein;


RESOLVED FURTHER that a copy of this Resolution be forwarded to the National Statistics Office, represented by its Administrator and Civil Registrar General **CARMELITA N. ERICTA** to manifest adherence of the Municipality of Narvacan, Ilocos Sur to the Memorandum of Agreement (MOA).
