RESOLUTION REQUIRING MR. AND MRS. WILLIAM BELLO OF BARANGAY AMBULOGAN TO SECURE THE NECESSARY REQUIREMENTS PRIOR TO THE OPERATION OF THEIR RICE MILL BUSINESS

WHEREAS, the Barangay Council of Ambulogan sent a letter to the Department of Environment and Natural Resources – Environmental Management Bureau, Regional Office No. 1, San Fernando City, La Union requesting the said office to conduct an ocular inspection of the rice mill of Mr. and Mrs. William Bello in Sitio Labuac of the same barangay; copy of the letter-request was furnished to the Sangguniang Bayan of this municipality;

WHEREAS, the Barangay Council of Ambulogan protests the operation of the said rice mill for it poses health problems, it, being located within a residential area, causing noise, pollution and skin itch;

WHEREAS, accordingly, the rice mill, operating a few weeks now, has no Environmental Compliance Certificate (ECC) and has no business permit from the Office of the Mayor;


WHEREAS, the Sangguniang Bayan, through the Committee on Health and Sanitation chaired by SBM Thelma C. Copiozo, made an investigation and found out that the said rice mill is truly operating illegally;

NOW THEREFORE, on motion duly seconded, the Sangguniang Bayan of Narvacan **RESOLVED AS IT IS HEREBY RESOLVED** to require Mr. and Mrs. William Bello of Barangay Ambulogan to secure the necessary requirements prior to the operation of their rice mill business;

RESOLVED FURTHER that copies of this Resolution be forwarded to Mr. and Mrs. William Bello and to the Provincial Environment and Natural Resources Office, Vigan City, for their information and appropriate actions;


