RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) ON THE SHARING OF DATA GENERATED FROM THE NATIONAL HOUSEHOLD TARGETING SYSTEM FOR POVERTY REDUCTION (NHTS-PR)

WHEREAS, the Department of Social Welfare and Development (DSWD) has a mandate to provide assistance to local government units, non-government organizations, other national government agencies, people's organizations, and other members of civil society in effectively implementing programs, projects and services that will alleviate poverty and empower disadvantaged individuals, families and communities for an improved quality of life;

WHEREAS, the Municipality of Narvacan has a mandate to participate actively in the implementation of national programs and projects;

WHEREAS, the DSWD maintains a database on Filipinos through its National Household Targeting System for Poverty Reduction (NHTS-PR);

WHEREAS, through the Memorandum of Agreement, the Municipality of Narvacan shall be allowed access to the data maintained under NHTS-PR;


WHEREAS, the Municipality of Narvacan shall use the information from the data maintained under NHTS-PR solely for baselining purposes so that it can set targets on how it can contribute to the achievement of the national goals in areas affecting children's well-being and capable and sustainable families;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the Municipal Mayor **ZURIEL S. ZARAGOZA** to enter into a Memorandum of Agreement with the Department of Social Welfare and Development (DSWD) on the sharing of data generated from the National Household Targeting System for Poverty Reduction (NHTS-PR);

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the Department of Social Welfare and Development, represented by **CORAZON JULIANO - SOLIMAN**, Secretary, to manifest adherence of the Municipality of Narvacan, Ilocos Sur to the Memorandum of Agreement.
