RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE I FOR THE IMPLEMENTATION OF THE SUPPLEMENTARY FEEDING PROGRAM

WHEREAS, prevalence of under and over nutrition still persists among Filipino children according to data from the 7th National Nutrition Survey conducted by the Food and Nutrition Research Institute of the Department of Science and Technology;

WHEREAS, the latest survey of the Family Income and Expenditure Surveys (FIES) conducted by the National Statistics Office reported that about 11% of Filipino families had incomes that cannot buy the food needed by family members for nutritional well-being and health;

WHEREAS, the Department of Social Welfare and Development is providing nutrition services to its clients at the local level through the center-based and community-based services in partnership with Non-Government Organizations under the Program Management Bureau, such as the Food for School and Healthy Start Feding Program in day care centers which were previously implemented nutrition programs of the Department;

WHEREAS, the President's State of the Nation Address (SONA) in July 26, 2010, emphasized that the thrust of his Administration is to strengthen and maximize Public-Private Partnerships along implementation of various programs and projects. As a response, a meeting was held on August 9, 2010, regarding the opportunities for partnership between DSWD and private sector partners on supplemental feeding;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the Municipal Mayor **ZURIEL S. ZARAGOZA** to enter into a Memorandum of Agreement with the Department of Social Welfare and Development (DSWD) Regional Office I for the implementation of the Supplementary Feeding Program;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the DSWD Regional Office I, represented by its Regional Director **MARLENE FEBES D. PERALTA,** OIC, to manifest adherence of the Municipality of Narvacan, Ilocos Sur to the Memorandum of Agreement.
