RESOLUTION ALLOCATING FUNDS FOR MUNICIPAL DEVELOPMENT PROJECTS IN THE AMOUNT OF TWO MILLION THREE HUNDRED SEVENTY SIX THOUSAND EIGHT HUNDRED TWENTY FIVE PESOS (P2,376,825.00) REPRESENTING THE CY 2010 SHARE OF THIS MUNICIPALITY FROM THE BURLEY AND OTHER NATIVE TOBACCO EXCISE TAX PURSUANT TO REPUBLIC ACT 8240

WHEREAS, the Municipal Administration has identified priority projects to sustain its development efforts thereby strengthening the economy of the municipality;

WHEREAS, the Members of the Sangguniang Bayan fully support the development agenda of the Municipal Administration;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to appropriate the amount of Two Million Three Hundred Seventy Six Thousand Eight Hundred Twenty Five Pesos (P2,376,825.00) representing the CY 2010 share of this municipality from the Burley and other native tobacco excise tax pursuant to Republic Act 8240;


RESOLVED FURTHER to enact the corresponding appropriation ordinance, to wit:




