RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO LEASE THE NORTHEASTERN PART OF THE NARVACAN MALL AS PARKING TERMINAL FOR BUSES

WHEREAS, the property lot located at Barangay Margaay, covered by Tax Declaration No. 018-01464 and Original Certificate of Title No. 83, owned by the municipal government of Narvacan was developed into a commercial complex and became the site of a shopping mall, otherwise known as 'Narvacan Mall' where mercantile spaces are made available and offered for lease to the public for business endeavors;

WHEREAS, the Honorable Zuriel S. Zaragoza, by virtue of the authority granted him by law, has been given full powers of supervision and discretion to formulate and/or implement such other policies and guidelines that will regulate business enterprises and economic activities at the Narvacan Mall;

WHEREAS, a portion of the commercial complex has been identified as, and allocated for Narvacan Mall Parking Terminal;

WHEREAS, a contract of lease shall be drawn in the amount of Ten Thousand Pesos (P10,000.00) and the operation of the bus terminal shall be subject to the terms and conditions stated in the contract of lease;


WHEREAS, this Resolution authorizes the Municipal Mayor Zuriel S. Zaragoza to enter into a negotiated contract with the interested parking terminal operator who wants to occupy the proposed parking terminal at the Narvacan Mall;

NOW THEREFORE, the Sangguniang Bayan of Narvacan, Ilocos Sur, **RESOLVED AS IT IS HEREBY RESOLVED** to authorize the Municipal Mayor Zuriel S. Zaragoza to lease the northeastern part of the Narvacan Mall as parking terminal for buses;






