**RESOLUTION ALLOCATING FUNDS FOR MUNICIPAL DEVELOPMENT PROJECTS IN THE AMOUNT OF SEVENTEEN MILLION ONE HUNDRED EIGHT THOUSAND FOUR HUNDRED THIRTEEN PESOS (PhP 17,108,413.00) REPRESENTING THE DIRECT SHARE OF THE MUNICIPALITY OF NARVACAN FROM THE TOBACCO EXCISE TAX PURSUANT TO REPUBLIC ACT 7171 FOR THE CALENDAR YEAR 2011**


**RESOLVED FURTHER** to enact the corresponding appropriation ordinance, to wit:




