RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) FOR ITS FINANCIAL ASSISTANCE IN THE AMOUNT OF FIFTY MILLION PESOS (P50M) FOR THE REHABILITATION/REPAIR OF THE SEAWALL IN BARANGAY SAN PEDRO THIS MUNICIPALITY

WHEREAS, the Municipal Administration has placed on top of its priority development agenda the rehabilitation/repair of the seawall in Barangay San Pedro which was damaged by Typhoon Pepeng and was devastated by the storm surge caused by Typhoon Juan;

WHEREAS, the severe devastation of the seawall causes the washout and damage to many houses prompting residents to leave their belongings and proceed to safer grounds;

WHEREAS, high waters from the South China Sea erode the destroyed seawall as well as the sand bags put up by the barangay folks for their temporary protection;

WHEREAS, the rehabilitation/repair of the said seawall is constrained by financial limitation as the Municipal Administration depends on financial assistance from the national government that is ever supportive of our development efforts;

WHEREAS, the Municipal Administration urgently needs development funds to meet the urgency of the said project in order to protect Barangay San Pedro in the face of widespread coastal and environmental degradation;

WHEREAS, the Sangguniang Bayan of Narvacan, Ilocos Sur trusts in the sincere concern of the Department of Public Works and Highways (DPWH) in sharing allocation to finance vital countryside infrastructure programs;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to earnestly request the Department of Public Works and Highways (DPWH), for its financial assistance in the amount of Fifty Million Pesos (P50M) for the rehabilitation/repair of the seawall in Barangay San Pedro this municipality;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the **Honorable Rogelio L. Singson,** Secretary, Department of Public Works and Highways (DPWH), for his utmost attention and immediate approval.
