**RESOLUTION EARNESTLY REQUESTING THE NATIONAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (NDRRMC), FOR ITS FINANCIAL ASSISTANCE IN THE AMOUNT OF TEN MILLION PESOS (P10M) FOR THE REHABILITATION/REPAIR OF THE SEAWALL IN BARANGAY SAN PEDRO THIS MUNICIPALITY**

**WHEREAS**, the Municipal Administration has placed on top of its priority development agenda the rehabilitation/repair of the seawall in Barangay San Pedro which was damaged by Typhoon Pepeng and it was devastated by the storm surge caused by Typhoon Juan;

**WHEREAS**, the severe devastation of the seawall causes the washout and damage to many houses prompting residents to leave their belongings and proceed to safer grounds;

**WHEREAS**, high waters from the South China Sea erode the destroyed seawall as well as the sand bags put up by the barangay folks for their temporary protection;

**WHEREAS**, the rehabilitation/repair of the said seawall is constrained by financial limitation as the Municipal Administration depends on financial assistance from the national government that is ever supportive of our development efforts;

**WHEREAS**, the Municipal Administration urgently needs development funds to meet the urgency of the said project in order to protect Barangay San Pedro in the face of widespread coastal and environmental degradation;

**WHEREAS**, the Sangguniang Bayan of Narvacan, Ilocos Sur trusts in the sincere concern of the National Disaster Risk Reduction and Management Council (NDRRMC) in sharing allocation to finance vital countryside infrastructure programs;

**WHEREAS**, the municipal administration commits that of the total amount in which the NDRRMC will provide forty percent (40%), the project will be completed;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to earnestly request the National Disaster Risk Reduction and Management Council (NDRRMC), for its financial assistance in the amount of Ten Million Pesos (P10M) for the rehabilitation/repair of the seawall in Barangay San Pedro this municipality;

**RESOLVED FURTHER**, that a copy of this Resolution be forwarded to the **Honorable Voltaire T. Gazmin**, Chairman, National Disaster Risk Reduction and Management Council, for his utmost attention and immediate approval.
