RESOLUTION EARNESTLY REQUESTING THE HONORABLE VIRGILIO R. DELOS REYES, SECRETARY, DEPARTMENT OF AGRARIAN REFORM, FOR HIS FINANCIAL ASSISTANCE IN THE AMOUNT OF TEN MILLION PESOS (P10,000,000.00) FOR THE REHABILITATION/IMPROVEMENT OF NORTH QUINARAYAN COMMUNAL IRRIGATION SYSTEM AND SOUTH QUINARAYAN COMMUNAL IRRIGATION SYSTEM, THIS MUNICIPALITY

WHEREAS, the rehabilitation/improvement of both the North and South Quinarayan Communal Irrigation Systems at Barangay Quinarayan is one of the top priorities in the Infrastructure and Irrigation Program of the Municipal Administration;

WHEREAS, when fully realized, the said projects will provide better and sufficient irrigation facilities, thereby enhancing economic growth and development of the whole community;

WHEREAS, the realization of the projects is constrained by financial limitation as the Municipal Administration depends on financial assistance from the national government that is ever supportive of our development efforts;

WHEREAS, the Municipal Administration urgently needs development funds to satisfy the needs of our constituents for better irrigation facilities, a vital infrastructure support to accelerate development of Agriculture in the countryside, in line with the economic development program of the national government;

WHEREAS, the Sangguniang Bayan of Narvacan, Ilocos Sur trusts in the sincere concern of the **Honorable Virgilio R. Delos Reyes** in sharing allocation to finance vital countryside infrastructure and agriculture programs;


