**RESOLUTION EARNESTLY REQUESTING THE HONORABLE TEOFISTO D. GUINGONA III, SENATOR, REPUBLIC OF THE PHILIPPINES, FOR HIS FINANCIAL ASSISTANCE IN THE AMOUNT OF SIXTY MILLION PESOS (P60,000,000.00) FOR THE CONSTRUCTION OF A MULTI-PURPOSE BUILDING, VARIOUS FARM-TO-MARKET ROADS AND FLOOD CONTROL FACILITIES IN THIS MUNICIPALITY**

**WHEREAS**, the Municipal Administration has identified priority projects to sustain its development efforts thereby strengthening the economy of the municipality;

**WHEREAS**, the Municipal Administration has included on these priority projects the construction of a multi-purpose building, various farm-to-market roads and flood control facilities in this municipality;

**WHEREAS**, this goal, however, is constrained by financial limitation as the Municipal Administration depends on financial assistance from the national government that is ever supportive of our development efforts;

**WHEREAS**, the Municipal Administration urgently needs development funds to finance the abovementioned projects that need the amount of sixty million pesos (P 60,000,000.00), the breakdown as follows: multi-purpose building – 20M; farm-to-market roads – 30M and flood control facilities – 10M;




