**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE BUREAU OF SOILS AND WATER MANAGEMENT FOR THE IMPLEMENTATION OF THE ESTABLISHMENT OF COMPOSTING FACILITY FOR BIODEGRADABLE WASTES (CFBW)**

**WHEREAS**, the BSWM, in support to RA10068 otherwise known as the "Organic Agriculture Act of 2010" ("RA10068") will implement the establishment of Composting Facility for Biodegradable Wastes ("CFBW") under the National Organic Agricultural Program ("NOAP");

**WHEREAS**, the BSWM advocates the utilization of organic fertilizers as one of the methods to minimize groundwater pollution, restore soil fertility, reduce the vulnerability of marginal farmers on the high cost of chemical fertilizers, and promote the gradual adoption of Organic Agriculture nationwide;

**WHEREAS**, Section 17 of RA 9003 states that one of the components of the LGU's Solid Waste Management is the processing of waste wherein it shall define the methods and facilities required to process the solid waste, including the use of intermediate treatment facilities for composting, recycling, conversion and other waste processing systems;

**WHEREAS**, the LGU has the logistical capability to handle the establishment, operation, maintenance and management of the CFBW;


