## RESOLUTION NO. 21 Series of 2016

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT BY ITS REGIONAL DIRECTOR DIR. MARCELO NICOMEDES J. CASTILLIO REGIONAL DIRECTOR FIELD OFFICE 1 FOR THE IMPLEMENTATION OF SUSTAINABLE LIVELIHOOD PROGRAM (SLP)

**WHEREAS**, Section 3 of Republic Act 5146 otherwise known as the Social Welfare Act mandates the DSWD to develop and implement a comprehensive social welfare program designed to uplift the living conditions of the distressed Filipinos especially those who are handicapped by reason of poverty;

**WHEREAS**, pursuant to the above mandate, the DSWD through it Sustainable Livelihood Program (SLP) aims to improve the socio-economic capacity of the program participants through microenterprise development and employment facilitation activities that shall ultimately provide a sustainable income source;

**WHEREAS**, LGU Narvacan, Narvacan, Ilocos Sur contributes to the same advocacy by providing the people of the Narvacan, Ilocos Sur a fast, accurate, effective and efficient delivery of public service by service-focused employees and officials;

**WHEREAS**, Republic Act 7160 otherwise known as the Local Government Code provides for the consultation and coordination with the Local Government Units on any projects of the national government agencies;

**WHEREAS**, the DSWD and the Local Government of Narvacan recognize the need to strengthen the socio-economic capacity of the poor by linking community-based services in the Philippines with the social network of households enrolled in the country's Conditional Cash Transfer (CCT) Program or *Pantawid Pamilyang Pilipino Program*;

**NOW THEREFORE**, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorized the Honorable Municipal Mayor of the Municipality of Narvacan, Province of Ilocos Sur, to enter into a Memorandum of Agreement with the Department of Social Welfare and Development by its Regional Director Dir. Marcelo Nicomedes J. Castillio Regional Director Field Office 1, for the implementation of Sustainable Livelihood Program (SLP),
