RESOLUTION ALLOCATING THE 40% DIRECT SHARE OF THE MUNCIPALITY OF NARVACAN, ILOCOS SUR FROM THE EXCISE TAX ON LOCALLY MANUFACTURED VIRGINIA-TYPE CIGARETTES UNDER RA NO. 7171

WHEREAS, pursuant to the provisions of RA No. 7171, the Municipality of Narvacan, Ilocos Sur is a beneficiary of the 40% Share of Cities and Municipality From the Excise Tax on Locally Manufactured Virginia – Type Cigarettes;

WHEREAS, the fund shall be utilized to advance the self-reliance of the local Narvacan tobacco farmers through the following projects to wit: a) livelihood projects enhancing the tobacco farmers' income, b) projects undertaken by cooperatives compliant with all documentation requirements, c) agro-industrial projects involving the tobacco farmers in the management and subsequent ownership of these projects and, d) infrastructure projects such as Farm to Market Roads;
