RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY (TIEZA) FOR THE CONSTRUCTION AND ESTABLISHMENT OF THE NARVACAN TOURISM INFORMATION CENTER AND THE BUILDING OF A TOURISM REST AREA (GREEN RESTROOM) IN NARVACAN, ILOCOS SUR

WHEREAS, in accordance with its mandate to develop tourism infrastructure projects in the country, the Tourism Infrastructure and Enterprise Zone Authority (TIEZA), a government-owned and controlled corporation shall fund the construction and establishment of the Narvacan Tourism Information Center and the Building of a Tourism Rest Area (Green Restroom) in Narvacan, Ilocos Sur;

WHEREAS, the Tourism Infrastructure and Enterprise Zone Authority (TIEZA) and the Municipality of Narvacan, Ilocos Sur have agreed to undertake the Construction of the Narvacan Tourism Information Center and the Tourism Rest Area (Green Restroom) for the benefit and enjoyment of foreign as well as domestic tourist and the general public, over and above the economic benefit it will bring to the LGU;

WHEREAS, the PROJECT shall be implemented by the Municipality thru TRANSFER OF FUND in the amount of **FIVE MILLION PESOS (Php 5,000,000.00)** for the purpose, and upon completion, the same shall be delivered and entrusted to the Municipality, whom then shall maintain, operate, manage and administer upon its turn-over by TIEZA;


