RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE NATIONAL TOBACCO ADMINISTRATION FOR THE IMPLEMENTATION OF THE IRRIGATION SUPPORT PROJECT FOR SMALL TOBACCO FARMERS (ISPSTF)

WHEREAS, the National Tobacco Administration has pursued under its Integrated Farming and Other Income Generating Activities Project (IFOIGAP), an Irrigation Support Project for Small Tobacco Farmers, in support of the Market-Driven Quality Production and Food Sufficiency Program of the Government, with funding support from the DBM, from the NTA's Tobacco Fund/Special Account in the General Fund (SAGF 151);

WHEREAS, the Local Government Code of 1991 (RA 7160) provides that the Local Government Units (LGUs) shall also exercise other powers and discharge such other functions and responsibilities that are necessary, appropriate or incidental to efficient and effective provision of the basic facilities and services, that include among others, on agriculture, barangay irrigation systems, soils and water utilization and conservation projects; and on infrastructure, construction/rehabilitation and maintenance of small water impounding projects, rainwater collector and water supply systems and spring development;

WHEREAS, under the Magna Carta for Small Farmers (RA 7607), the government encourages small farmers to join or form irrigator's associations that will spearhead the construction of irrigation systems and promote participation of farmers that will develop their capabilities to eventually assume operation and maintenance of irrigation systems;

WHEREAS, the NTA, Local Government Unit of Narvacan and Farmers Association of Narvacan desire to embark collectively in the implementation of the Irrigation Support Project for Small Tobacco Farmers (ISPSTF);

WHEREAS, the following projects have been approved for funding and implementation under the ISPSTF with a total approved budget of Php36,260,000.00:

3. Construction/Rehabilitation of Camarao Small Diversion Dam II - Brgy. Camarao	River, watershed runoff and seepage from the mountain	Php. 9,800,000.00
4. Construction/Rehabilitation of Banglayan Small Diversion Dam II - Brgy. Banglayan	River, watershed runoff and seepage	Php. 9,800,000.00

Zaragoza to enter into a memorandum of agreement with the National Tobacco Administration for the implementation of the Irrigation Support Project for Small Tobacco Farmers (ISPSTF);

RESOLVED FINALLY that a copy of this Resolution be furnished to the National Tobacco Administration, represented by **EDGARDO D. ZARAGOZA**, Administrator and Vice Chairman of the Governor Board, to manifest willingness and capability of the Municipality of Narvacan, Ilocos Sur, as a partner of this endeavor which benefits the whole community.






