RESOLUTION CREATING SIX (6) NEW POSITIONS IN THE LOCAL GOVERNMENT UNIT OF NARVACAN, ILOCOS SUR

WHEREAS, it is the policy of the Municipality to determine the offices, positions and salaries for the proper conduct of programs, projects services and activities of the Municipal Government;

WHEREAS, for the judicious improvement of services to the people there are six (6) new positions to be created;

WHEREAS, the positions to be created are as follows:

1. Dentist II – SG 16/1, New item, under the office of the Rural Health Unit with salary of Three Hundred Twenty Two Thousand Five Hundred Thirty Six Pesos (P322,536.00) per annum.

2. Nurse II – SG 15/1 New Item, with salary of Two Hundred Ninety Eight Thousand Six Hundred Forty Four Pesos (P298,644.00) per annum.

3. Nurse II = SG 15/1 New Item, with salary of Two Hundred Ninety Eight Thousand Six Hundred Forty Four Pesos (P298,644.00) per annum.

4. Local DRRM Officer III – SG 18/1 New item, under the office of the Municipal Mayor with a salary of Three Hundred Nineteen Thousand Seven Hundred Seventy Six Pesos (P319,776.00) per annum.

5. Electrical Inspector II – SG 8/1 New item, under the office of the Market Enterprise Development and Management with a salary of One Hundred Fifty Two Thousand Two Hundred Ninety Two Pesos (P152,292.00) per annum.

6. Local Revenue Collection Officer I – SG 11/1 New item, with a salary of One Hundred Eighty Thousand Two Hundred Four Pesos (P189,204.00) per annum.


A grand total PS appropriation of One Million Five Hundred Eighty One Thousand and Ninety Six Pesos (P1,581,096.00).
