RESOLUTION REQUESTING HON. SECRETARY EMILIA T. BONCODIN, DEPARTMENT OF BUDGET AND MANAGEMENT THE RELEASE AND MONETIZATION OF R.A. 7171 BALANCES FOR CY 2001 AND CY 2002 FOR THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, RA 7171 fund is really of great help to the local government particularly for the realization of infrastructure, agro-industrial, livelihood and development projects;

WHEREAS, the municipality is financially constrained to fund construction and improvement of farm-to-market and feeder roads, irrigations, minor bridges and livelihood projects for micro enterprises as well as the provision of farm equipment to small farmers to support the development of the local agriculture sector;




RESOLVED FINALLY to present this resolution to Hon. Emilia T. Boncodin, Secretary, Department of Budget and Management for her favorable action and approval.
