RESOLUTION ALLOCATING FUNDS FOR THE PURCHASE OF MEDICINES FOR THE RURAL HEALTH UNIT OF THE LOCAL GOVERNMENT OF NARVACAN, ILOCOS SUR SOURCED FROM THE LOCAL GOVERNMENT SERVICE EQUALIZATION FUND OF 2003

WHEREAS, the promotion of better health and the maintenance of good health is a priority concern of the Municipal Administration of Narvacan, Ilocos Sur;

WHEREAS, the Rural Health Unit of the Local Government of this Municipality is mandated to carry out basic health-care services of the Municipal Administration;

WHEREAS, the Local Government through the Rural health Unit is providing free basic medicines to indigent patients who avail of its various basic medical services;

NOW THEREFORE, on motion duly seconded by the Body, BE IT RESOLVED AS IT IS HEREBY RESOLVED to appropriate the amount of P693,985.00 for the exclusive purchase of basic medicines for use by the Rural Health Unit of the Local Government of Narvacan, Ilocos Sur;

RESOLVED FURTHER to enact the corresponding ordinance, to wit:


AN ORDINANCE APPROPRIATING SIX HUNDRED NINETY THREE THOUSAND NINE HUNDRED EIGHTY FIVE PESOS (P693,985.00) FROM THE 2003 LOCAL GOVERNMENT SERVICE EQUALIZATION FUND DUE THE MUNICIPALITY OF NARVACAN, ILOCOS SUR EXCLUSIVELY FOR THE PURCHASE OF MEDICINES FOR USE BY THE RURAL HEALTH UNIT

BE IT ENACTED by the members of the Sangguniang Bayan of Narvacan, Ilocos Sur to appropriate the amount of P693,985.00 chargeable against the 2003 Local Government Service Equalization Fund which amount shall be allotted for the purchase of various basic medicines for use by the Rural Health Unit of the Local Government of Narvacan, Ilocos Sur;


