RESOLUTION AUTHORIZING MUNICIPAL MAYOR CHARITO S. ZARAGOZA TO DONATE A PARCEL OF LOT SITUATED IN THE SULVEC ELEMENTARY SCHOOL TO THE DEPARTMENT OF EDUCATION FOR USE AS SITE OF THE PROPOSED SULVEC INTEGRATED HIGH SCHOOL OF THIS MUNICIPALITY

WHEREAS, the members of the Sangguniang Bayan of Narvacan, Ilocos Sur are cognizant of the importance of providing accessible education opportunities to the young citizens of the municipality;

WHEREAS, this Sangguniang Bayan has earlier passed Resolution No. 102 series of 2003 which requested Dr. Vilma Labrador, Regional Director of the Department of Education, to effect the creation and establishment of an integrated high school in Barangay Sulvec, this municipality;

WHEREAS, such school shall be constructed on a portion within the lot now being occupied by the Sulvec Elementary School;

WHEREAS, such lot is wholly owned by the Municipality of Narvacan, Ilocos Sur under Tax Declaration No. 92-032-00540;

WHEREAS, the proposed high school shall be constructed utilizing Seven hundred fifty square meters;

NOW THEREFORE, on motion duly seconded, BE IT RESOLVED AS IT IS HEREBY RESOLVED TO AUTHORIZE MUNICIPAL MAYOR CHARITO S. ZARAGOZA TO DONATE A PARCEL OF LOT TOTALLING SEVEN HUNDRED FIFTY SQUARE METERS SITUATED IN THE SULVEC ELEMENTARY SCHOOL TO THE DEPARTMENT OF EDUCATION FOR USE AS SITE OF THE PROPOSED LUNGOG INTEGRATED HIGH SCHOOL OF THIS MUNICIPALITY;


