RESOLUTION REQUIRING ALL DRIVERS AND/OR OPERATORS OF TRICYCLES FOR HIRE IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR TO SUBMIT RESULT OR CERTIFICATION OF DRUG TEST AS A VITAL REQUIREMENT IN THE ISSUANCE OF TRICYCLE FRANCHISES

WHEREAS, the Municipal Administration is intensifying and strengthening its campaign against illegal drugs in the municipality;

WHEREAS, there is a need to ascertain the well-being, sound mind and right attitude of drivers/operators of tricycles for hire in the municipality to be able to conduct safe driving on the road, ensuring as well the safety of the commuting public;

WHEREAS, tricycle drivers/operators must be free at all time from the influence of prohibited drugs and should never be involved in any illegal drug activity;


WHEREAS, only if tricycle drivers and/or operators will undergo drug test that we be assured of sound and healthy drivers who the public can entrust their lives to when travelling on these three-wheeler motorized vehicles;


