RESOLUTION ADOPTING **NARVACAN HYMN** AS THE OFFICIAL ANTHEM OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR AND REQUIRING THEREOF ITS SINGING DURING FLAG-RAISING CEREMONIES OF ALL LOCAL PUBLIC AND PRIVATE SCHOOLS OF ALL LEVELS AND DURING FORMAL PROGRAMS CONDUCTED IN THE MUNICIPALITY

WHEREAS, there is a need to inculcate the values of loyalty, patriotism and love of community in every citizen of the Municipality of Narvacan, Ilocos Sur;

WHEREAS, these aforesaid values may be translated into action by way of music through the **NARVACAN HYMN** composed by Mrs. Gemma Calura-Albayalde and set into music by Mr. Edwin Pascua;

WHEREAS, the **NARVACAN HYMN** embodies our "glorious past," sense of patriotism and love of Narvacan;

WHEREAS, the lyrics of the NARVACAN HYMN go as –

Dignified with the passing time.

Symbol of valor and ideals.
The scenic spots, historic landmarks;

Heed thy call ever vigilant;
Return to thee pledge of our hearts.

NOW THEREFORE, on motion of Councilor Irvin Lim, duly seconded by the Body, BE IT RESOLVED AS IT IS HEREBY RESOLVED to adopt **NARVACAN HYMN** AS THE OFFICIAL ANTHEM OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR AND REQUIRING THEREOF ITS SINGING DURING FLAG-RAISING CEREMONIES OF ALL LOCAL PUBLIC AND PRIVATE SCHOOLS OF ALL LEVELS AND DURING FORMAL PROGRAMS CONDUCTED IN THE MUNICIPALITY;

RESOLVED FURTHER that the Municipal Administration shall effect the dissemination of the presence of our official local anthem, **NARVACAN HYMN**, in ways it deems appropriate.


RESOLVED FINALLY that copies of this Resolution be furnished all concerned and interested parties for their information and appropriate action.


