- A public or private school or non-government organization must first secure endorsement from the Municipal Social Work and Development Office.
- Afterwhich, the endorsement must be presented to the Office of the Mayor for the issuance of Mayor's permit to solicit.
- If the endorsement is approved by the Municipal Mayor, private or public school or non-government organization shall pay the appropriate permit fee based on the assessment of the Licensing Officer.
- The Mayor's Permit to solicit will indicate the length of the period of solicitation.

- The Mayor's Permit to solicit will indicate the length of the period of solicitation.
