RESOLUTION ADOPTING REGULATORY MEASURES IN THE SOLICITATION OF CASH AND KIND FOR PURPOSES OF RAISING FUNDS BY PUBLIC AND PRIVATE SCHOOLS AND NON-GOVERNMENT ORGANIZATIONS OPERATING IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR, REVISING THEREOF RESOLUTION NO. 98-06 SERIES OF 1998

WHEREAS, the members of the Municipal Council feel the need to regulate the solicitation of cash and kind by public and private schools and non-government organizations for purposes of raising funds, be it for projects, popularity contests, raffle prizes, prizes intended for sports, cultural, literary and arts competitions;

WHEREAS, appropriate measures be adopted to regulate solicitation activities in the municipality undertaken by public and private schools and non-government organizations;


NOW THEREFORE, on motion of the Body, duly seconded, BE IT RESOLVED AS IT IS HEREBY RESOLVED to adopt the following regulatory measures in the solicitation of cash and kind for purposes of raising funds by public and private schools and non-government organizations operating in the municipality:

1. A public or private school or non-government organization must first secure endorsement from the Municipal Social Work and Development Office.
2. Afterwhich, the endorsement must be presented to the Office of the Mayor for the issuance of Mayor's permit to solicit.
3. If the endorsement is approved by the Municipal Mayor, private or public school or non-government organization shall pay the appropriate permit fee based on the assessment of the Licensing Officer.
4. The Mayor's Permit to solicit will indicate the length of the period of solicitation.


