JOINT RESOLUTION URGING FOR THE SPEEDY RESOLUTION OF ALL DRUGS-RELATED CASES FILED AT THE BRANCHES 72 AND 22 OF THE REGIONAL TRIAL COURTS HOUSED AT THE NARVACAN JUSTICE HALL

WHEREAS, the problem on illegal drugs continues to beset the municipality of Narvacan which poses a great threat to the lives of the people especially the youth who are susceptible to the temptations of using and abusing drugs;

WHEREAS, it is discouraging to note that illegal drugs are still being traded despite police efforts to curb the proliferation of prohibited drugs particularly *shabu* in the municipality;

WHEREAS, there are suspected persons who have violated Republic Act 9165 otherwise known as the *Comprehensive Dangerous Drugs Act of 2002* and are now facing court charges at the Branches 72 and 22 of the Regional Trial Courts;

WHEREAS, these suspected persons may pose more harm than good if their cases are not solved in reasonable due time as they may have the chance to continue using or selling illegal drugs;

WHEREAS, we envision a Narvacan that is free from illegal drugs and all forms and shades of prohibited drugs must be eradicated;


WHEREAS, one effective measure to achieve this vision is to send to jail suspected drug pushers/ users who have been proven guilty beyond reasonable doubt;
