**RESOLUTION EARNESTLY REQUESTING HER EXCELLENCY GLORIA MACAPAGAL-ARROYO, PRESIDENT, REPUBLIC OF THE PHILIPPINES, THROUGH THE HONORABLE ARTHUR C. YAP, SECRETARY, DEPARTMENT OF AGRICULTURE, FOR HER FINANCIAL ASSISTANCE IN THE AMOUNT OF FIFTEEN MILLION PESOS (P15, 000,000.00) FOR THE REHABILITATION/CONSTRUCTION OF FLOOD CONTROL FACILITIES IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR**

**WHEREAS**, the Municipal Administration has placed on top of its development agenda the rehabilitation and construction of flood control facilities in the coastal barangays of the municipality which will protect the residents from disaster and flood waters coming from the South China Sea;

**WHEREAS**, this goal, however, is constrained by financial limitation as the Municipal Administration depends on financial assistance from the national government who is ever-supportive of our development effort;

**WHEREAS**, the Municipal Administration urgently needs development funds to meet the urgency of the said project in order to protect, of our coastal areas in the face of widespread coastal and environmental degradation;

**WHEREAS**, the Sangguniang Bayan of Narvacan, Ilocos Sur always trusts in the sincere concern of **Her Excellency Gloria Macapagal-Arroyo** in sharing allocation to finance vital countryside infrastructure programs;

**WHEREAS**, the Municipal Administration has identified the rehabilitation and construction of flood control facilities in the different coastal barangays of Narvacan that needs the amount of ten million pesos (P15, 000,000.00) to bankroll this part of the infrastructure program;


**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED TO EARNESTLY REQUEST HER EXCELLENCY GLORIA MACAPAGAL-ARROYO, PRESIDENT, REPUBLIC OF THE PHILIPPINES THROUGH THE HONORABLE ARTHUR C. 




