RESOLUTION EARNESTLY REQUESTING THE HON. ARTHUR C. YAP, SECRETARY, DEPARTMENT OF AGRICULTURE, THROUGH THE HON. RAMON N. GUICO Jr., NATIONAL PRESIDENT, LEAGUE OF MUNICIPALITIES OF THE PHILIPPINES (LMP), FOR HIS FINANCIAL ASSISTANCE AMOUNTING TO ONE MILLION PESOS (P 1,000,000.00) FOR THE PURCHASE OF 30 UNITS OF KULIGLIG FOR THE DIFFERENT BARANGAYS OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, the Municipal Administration has placed on top of its development agenda the purchase of 30 units of kuliglig for the different barangays of the municipality which will cater to the needs of the farmers;

WHEREAS, this goal, however, is constrained by financial limitation as the Municipal Administration depends on financial assistance from the national government who is ever-supportive of our development effort;

WHEREAS, the Municipal Administration urgently needs development funds to meet the urgency of the said project for better farm machineries, a vital support to accelerate development of Agriculture in the countryside in line with the economic development program of the national government;

WHEREAS, the Sangguniang Bayan of Narvacan, Ilocos Sur always trusts in the sincere concern of the **Hon. Arthur C. Yap** in sharing allocation to finance vital countryside Agricultural programs;

WHEREAS, the Municipal Administration has identified the purchase of 30 units of kuliglig for the different barangays of Narvacan that needs the amount of One Million Two Hundred Thousand Pesos (P 1,200,000.00) to bankroll this part of the Agricultural program;

WHEREAS, the Municipal Administration will set its counterpart amounting to Two Hundred Thousand Pesos (P 200,000.00) for the realization of this project;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED TO EARNESTLY REQUEST THE HON. ARTHUR C. YAP, SECRETARY, DEPARTMENT OF AGRICULTURE, THROUGH THE HON. RAMON N. GUICO JR., NATIONAL PRESIDENT, LEAGUE OF MUNICIPALITIES OF THE PHILIPPINES (LMP), FOR HIS FINANCIAL ASSISTANCE AMOUNTING TO 1 MILLION PESOS (P 1,000,000.00) FOR THE PURCHASE OF 30 UNITS OF KULIGLIG FOR THE DIFFERENT BARANGAYS OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR;


