**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR EDGARDO D. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD UNIT I (DA RFU-I) FOR THE PURPOSE SPECIFIED HEREIN**

**WHEREAS**, the Department of Agriculture (DA) through its Regional Filed Unit I (RFU-I) is implementing the Ginintuang Masaganang Ani (GMA) Program, whereby one of its major support components is the provision of market access infrastructure like Farm to Market Road (FMR);

**WHEREAS**, in the provision of market access infrastructure, the DA RFU-I shall allocate an amount of Five Million Pesos (P 5,000,000.00) for the construction and/or improvement/rehabilitation of the FMR;

**WHEREAS**, to ensure efficient and effective transport and delivery of agricultural products in the trade and market center, the LGU intends to avail of the said assistance;

**WHEREAS**, this Resolution authorizes Mayor Edgardo D. Zaragoza to enter into a Memorandum of Agreement (MOA) with the DA RFU-I which stipulates that the DA RFU-I shall transfer 90% of the fund to LGU-Narvacan upon approval of the plans/designs and specifications, POW and perfection of the MOA, and the remaining 10% shall be paid upon completion of the project and submission of audited financial liquidation report of the total amount of "DA RFU-I" share;

**WHEREAS**, the said MOA stipulates also that the LGU- Narvacan shall submit duly audited financial liquidation reports of the total DA RFU-I share, every after payment made by LGU-Narvacan until the project is 100% completed and the total DA RFU-I share is liquidated;

**NOW THEREFORE**, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the Municipal Mayor Edgardo D. Zaragoza to enter into a memorandum of agreement with the Department of Agriculture Regional Filed Unit I (DA RFU-I) for the purpose specified herein;


**RESOLVED FURTHER** that a copy of this Resolution be forwarded to the DA RFU-I, represented by its Regional Executive Director **ATTY. CIPRIANO G. SANTIAGO** to manifest adherence of the Municipality of Narvacan, Ilocos Sur to the Memorandum of Agreement (MOA).




