**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR EDGARDO D. ZARAGOZA OF THE MUNICIPALITY OF NARVACAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRARIAN REFORM (DAR) FOR THE CONSTRUCTION/IMPROVEMENT OF LUNGOG-CAMARAO FARM-TO-MARKET ROAD**

**WHEREAS**, the Department of Agrarian Reform (DAR), a government agency tasked to lead the implementation of the Comprehensive Agrarian Reform, collaborates with Local Government Units to assist in the implementation of support services such as infrastructure and agri-enterprise development projects;

**WHEREAS**, the Local Government Unit of Narvacan, Ilocos Sur signifies to be a conduit in implementing infrastructure projects like construction of roads and bridges which can serve a greater number of its constituents;

**WHEREAS**, the construction/improvement of Lungog-Camarao farm-to-market road is one of the top priorities in the Infrastructure Program of the Municipal Administration;

**WHEREAS**, when fully realized, the said project will provide better and faster means of transporting farm products to the market and will promote inter-trade relations with neighboring barangays, thereby enhancing economic growth and development of the whole community;

**WHEREAS**, the said project has been approved and the Department of Agrarian Reform has allocated the amount of One Million Pesos (P 1,000,000.00) for its realization;

**NOW THEREFORE**, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to pass this Resolution authorizing the Municipal Mayor Edgardo D. Zaragoza to enter into a memorandum of agreement with the DAR which stipulates among others that DAR shall provide the amount of One Million Pesos (P 1,000,000.00) for the construction/improvement of Lungog-Camarao Farm-to-Market road, to be implemented by the municipal government of Narvacan, Ilocos Sur;

**RESOLVED FURTHER** that upon signing of the MOA, the DAR Central Office shall download a mobilization fund amounting to 15% of the project fund and the subsequent release shall be based on the physical and financial report submitted by the Municipality of Narvacan;


**RESOLVED FINALLY** that a copy of this Resolution be furnished to DAR, represented by its Undersecretary for Finance, Management and Administration Office, **JEFFREY M. GALAN**, to manifest willingness and capability of the Municipality of Narvacan, Ilocos Sur, as a partner of this endeavor which benefits the whole community.




