RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR EDGARDO D. ZARAGOZA OF THE MUNICIPALITY OF NARVACAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL IRRIGATION ADMINISTRATION(NIA)FOR THE CONSTRUCTION OF SOUTH QUINARAYAN COMMUNAL IRRIGATION SYSTEM (CIS) AT BARANGAY QUINARAYAN, NARVACAN, ILOCOS SUR

WHEREAS, the National irrigation Administration (NIA), a government-owned agency tasked to lead the implementation of irrigation programs, collaborates with Local Government Units to assist in the implementation of support services such as irrigation facilities and agri-enterprise development projects;

WHEREAS, the Local Government Unit of Narvacan, Ilocos Sur signifies to be a conduit in implementing infrastructure projects like construction of irrigation facilities and diversion dams which can serve a greater number of its constituents especially the lowly farmers;

WHEREAS, the construction of the South Quinarayan Communal Irrigation System at Barangay Quinarayan is one of the top priorities in the Infrastructure and Irrigation Program of the Municipal Administration;

WHEREAS, when fully realized, the said project will provide better and accessible irrigation facilities, thereby enhancing economic growth and development of the whole community;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to pass this Resolution authorizing the Municipal Mayor Edgardo D. Zaragoza to enter into a memorandum of agreement with the NIA amounting to Four Million and Five Hundred Thousand Pesos (P 4,500,000.00) for the construction of the South Quinarayan Communal Irrigation System at Barangay Quinarayan, to be implemented by the municipal government of Narvacan, Ilocos Sur;

RESOLVED FURTHER that upon signing of the MOA, the NIA National Office shall transfer the Advice of Sub-Allotment (ASA) and all available funding check to the account of the municipal government of Narvacan, Ilocos Sur;

RESOLVED FINALLY that a copy of this Resolution be furnished to Hon. Carlos S. Salazar, OIC-Administrator of the National Irrigation Administration Office for his immediate approval and release of the corresponding fund.
