RESOLUTION EARNESTLY REQUESTING THE PROVINCIAL GOVERNMENT TO TRANSFER THE MANAGEMENT AND OPERATION OF CENTRAL ILOCOS SUR DISTRICT HOSPITAL (CISDH) TO THE LOCAL GOVERNMENT UNIT OF NARVACAN, ILOCOS SUR

WHEREAS, Central Ilocos Sur District Hospital (CISDH) is a government institution mandated to deliver health care services to the public, especially those coming from the low income bracket of the community;

WHEREAS, the Members of the Legislative Body take cognizance of the fact that CISDH is supposed to provide adequate and effective health services to its clients;

WHEREAS, CISDH is better kept and maintained if it is to be managed and operated by the Local Government Unit of Narvacan, Ilocos Sur;

WHEREAS, once in the LGU's hands, CISDH shall provide better and modern medical equipments and facilities to the needy public;

NOW THEREFORE, the Sangguniang Bayan of Narvacan, Ilocos Sur, in session duly assembled, and on motion duly seconded **RESOLVED AS IT IS HEREBY RESOLVED** to earnestly request the Provincial Government to transfer the management and operation of Central Ilocos Sur District Hospital (CISDH) to the Local Government Unit of Narvacan, Ilocos Sur;
