RESOLUTION REQUESTING THE LOCAL WATER UTILITIES ADMINISTRATION (LWUA) TO TRANSFER THE MANAGEMENT AND OPERATION OF THE NARVACAN WATER DISTRICT TO THE LOCAL GOVERNMENT UNIT OF NARVACAN, ILOCOS SUR

WHEREAS, the Local Water Utilities Administration (LWUA) is a specialized lending institution mandated by law to promote and oversee the development of provincial waterworks system in the Philippines;

WHEREAS, Narvacan Water District is a duly-formed Water District that has undergone the LWUA formation process and has been issued a Conditional Certificate of Conformance (CCC);

WHEREAS, Narvacan Water District at present is being governed by a five-man Board of Directors and managed by Engr. John Haskel Calpito who executes the policies set by the former;

WHEREAS, Narvacan Water District is better kept and maintained if it is to be managed and operated by the Local Government Unit of Narvacan, Ilocos Sur;

WHEREAS, once in the LGU's hands, Narvacan Water District shall provide better services to the water consumers/users, ensuring that water reaching their home is safe and water is there whenever it is needed;

NOW THEREFORE, the Sangguniang Bayan of Narvacan, Ilocos Sur, in session duly assembled, **RESOLVED AS IT IS HEREBY RESOLVED** to request the Local Water Utilities Administration (LWUA) to transfer the management and operation of the Narvacan Water District to the Local Government Unit of Narvacan, Ilocos Sur;

RESOLVED FURTHER that copies of this Resolution be forwarded to the **Hon. Orlando C. Hondrade**, Administrator of LWUA, and to all parties concerned for their information and appropriate action.
