RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR EDGARDO D. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD UNIT I (DA-RFU I) FOR THE CONSTRUCTION OF ONE (1) UNIT MULTI-PURPOSE DRYING PAVEMENT (MPDP) AT BRGY. PARPARIA THIS MUNICIPALITY

WHEREAS, the Department of Agriculture (DA) is providing integrated services to ensure the increase in farm productivity as well as real income of small farmers;

WHEREAS, the construction of one (1) unit Multi-Purpose Drying Pavement (MPDP) is a project for agricultural development and production;

WHEREAS, the Local Government Code of 1991 allows the national agency to complement national funded requests, facilities, programs and services jointly or with the assistance of the local government units;

WHEREAS, the DA-RFU I and the Local Government Unit of Narvacan, Ilocos Sur agreed to cooperate and jointly implement the above cited project;

WHEREAS, this Resolution authorizes Mayor Edgardo D. Zaragoza to enter into a Memorandum of Agreement (MOA) with the DA-RFU I which stipulates that the DA- RFU I shall transfer the amount of **ONE HUNDRED THOUSAND PESOS (Php100,000.00)** as its share for the construction of one (1) unit MPDP;

WHEREAS, the said MOA stipulates also that the Local Government Unit of Narvacan, Ilocos Sur shall provide the necessary counterpart fund amounting to **TWO HUNDRED THOUSAND SIX HUNDRED TWENTY SIX PESOS AND FIFTY NINE CENTAVOS (Php200,626.59)** either in cash, material and/or labor as reflected in the duly approved and concurred detailed cost estimates and program of work;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the Municipal Mayor Edgardo D. Zaragoza to enter into a memorandum of agreement with the Department of Agriculture Regional Filed Unit I (DA-RFU I) for the construction of one (1) unit Multi-Purpose Drying Pavement (MPDP) at Brgy. Parparia this municipality;

RESOLVED FURTHER that a copy of this Resolution be forwarded to the DA-RFU I, represented by its Regional Executive Director **ATTY. CIPRIANO G. SANTIAGO** to manifest adherence of the Municipality of Narvacan, Ilocos Sur to the Memorandum of Agreement (MOA).




