RESOLUTION ALLOCATING FUNDS FOR MUNICIPAL DEVELOPMENT PROJECTS IN THE AMOUNT OF SEVENTEEN MILLION ONE HUNDRED EIGHT THOUSAND FOUR HUNDRED THIRTEEN PESOS (PhP 17,108,413.00) REPRESENTING THE DIRECT SHARE OF THE MUNICIPALITY OF NARVACAN FROM THE TOBACCO EXCISE TAX PURSUANT TO REPUBLIC ACT 7171 FOR THE CALENDAR YEAR 2010

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to appropriate the amount of Seventeen Million One Hundred Eight Thousand Four Hundred Thirteen Pesos (PhP 17,108,413.00) representing the direct share of the Municipality of Narvacan from the tobacco excise tax pursuant to Republic Act 7171 for the calendar year 2010;


RESOLVED FURTHER to enact the corresponding appropriation ordinance, to wit:
