**WHEREAS**, the Members of the Sangguniang Bayan are cognizant of the need to provide the people better and secured place to conduct such important activities especially during rainy season;


**WHEREAS**, the construction of the municipal multi-purpose building/gymnasium will even serve as an income-generating establishment wherein big events of the municipality will be staged;
