ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE CBMS NETWORK COORDINATING TEAM OF THE ANGELO KING INSTITUTE FOR ECONOMIC AND BUSINESS STUDIES, DE LA SALLE UNIVERSITY, THE DILG THRU THE BLGD AND THE DILG REGIONAL OFFICE NO. I FOR THE INSTALLATION OF COMPUTER-BASED ADMINISTRATIVE SYSTEM IN THE MUNICIPALITY FOR EFFECTIVE GOVERNANCE**

**WHEREAS**, the Municipal Government of Narvacan assumes the primary responsibility for the provision of basic services and facilities and the improvement of the quality of life of the constituents and serves as the frontline institution towards the achievement of the MDGs and addressing poverty in the municipality;

**WHEREAS**, the CBMS Network Coordinating Team, of the Angelo King Institute for Economic Business Studies, De La Salle University-Manila is a group of researchers and policy analysts, under Poverty and Economic Policy (PEP) Network Program funded by the International Development Research Centre (IDRC)-Canada, who developed the CBMS methodology as part of its research program;

**WHEREAS**, the DILG through the Bureau of Local Government Development (BLGD) develops the following computer-based administrative system under the Enhancing-Local Management Information System (PMIS) which can be installed and implemented in the municipal government;

**WHEREAS**, the BLGD is further mandated to assist and strengthen the capabilities of the local government units particularly their administrative, technical and fiscal capabilities to enable them to effectively deliver basic services to the constituents;

**WHEREAS**, the information technology through the computer-based administrative systems is one tool of improving the administrative capabilities of the municipal government for effective governance;

**WHEREAS**, the Department of the Interior and Local Government (DILG) has the primary responsibility in localizing the MDGs and capacitating LGUs on poverty monitoring and planning using the Core Local Poverty Indicators Monitoring System (CLPIMS) which incorporated the Community-Based Monitoring System (CBMS) as its generation module for poverty baseline data and MDG benchmarks;

**NOW THEREFORE**, the Municipality of Narvacan, Ilocos Sur in its desire to adopt the said application systems and its accompanying policies, the Sangguniang Bayan Members of this municipality upon proper motion, duly seconded by the body, be it




