RESOLUTION EARNESTLY REQUESTING THE HON. FERDINAND MARCOS JR., SENATOR, REPUBLIC OF THE PHILIPPINES, FOR HIS FINANCIAL ASSISTANCE AMOUNTING TO THREE MILLION PESOS (Php 3,000,000.00) FOR THE CONSTRUCTION OF THE MUNICIPAL MULTI-PURPOSE BUILDING/GYMNASIUM

WHEREAS, the Members of the Sangguniang Bayan are cognizant of the need to provide the people better and secured place to conduct such important activities especially during rainy season;


WHEREAS, the construction of the municipal multi-purpose building/gymnasium will even serve as an income-generating establishment wherein big events of the municipality will be staged;






