WHEREAS, these dengue cases have alarmed the municipal administration and the association of barangay councils of the the possibility of an outbreak when not prevented;


WHEREAS, there is an imperative need to finance precautionary efforts and relief programs to affected areas and dengue victims;




The Department cannot offer any vaccine because it is not yet available and our last resort is **fumigation**. So we are more on the preventive measures, information and education campaign about cleanliness and the elimination of breeding places of Aedis Egypti mosquitoes and other insects.

With this, I highly recommend the purchase of REDISOL Anti-Dengue Reagents and for a simultaneous spraying and clean-up of every barangay to be initiated by the Local Government Unit.
