RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A SPECIAL FOREST LAND USE AGREEMENT (FLAg) WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES REGION I

WHEREAS, the Municipal Government of Narvacan, Ilocos Sur represented by the Hon. Zuriel S. Zaragoza, Municipal Mayor, plans to apply for a special Forest Land Use Agreement (FLAg) with the Department of Environment and Natural Resources Region I;

WHEREAS, the special Forest Land Use Agreement (FLAg) covers lot 29085 with an area of 16.0796 hectares located at Bantay Abot, Narvacan, Ilocos Sur;

WHEREAS, this Resolution authorizes the Municipal Mayor Zuriel S. Zaragoza to enter into a special Forest Land Use Agreement (FLAg) with the Department of Environment and Natural Resources Region I which stipulates that the Municipal Government of Narvacan, Ilocos Sur shall utilize the area only for the purpose for which the Agreement is granted;

WHEREAS, the said Agreement orders that construction by the Municipal Government of Narvacan, Ilocos Sur of any building of permanent charactec on the area granted shall be in accordance with the Comprehensive Management and Development Plan (CDMP) to be submitted to the Regional Executive Director of the DENR upon recommendation of RTD-FMS who shall prescribe the conditions under which it shall be constructed;

WHEREAS, the Agreement further requires the Municipal Government of Narvacan, Ilocos Sur to pay the annual gverment share/user's fee within thirty (30) days upon approval of the Agreement and annually thereafter, within he same month that the FLAg was issued based on the Five Percentum (5%) of the zonal value of the nearest commercial zone within the Barangay/Municipality or Province whichever is higher as determined by the Department of Finance/Bureau of Internal Revenue;

WHEREAS, the other conditions of the Agreement are fair, just, and in order;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the Municipal Mayor Zuriel S. Zaragoza to enter into a special Forest Land Use Agreement (FLAg) with the Department of Environment and Natural Resources Region I;

RESOLVED FINALLY that copies of this Resolution be forwarded to all persons and parties concerned to manifest adherence of the Municipal Government of Narvacan, Ilocos Sur to the conditions of the Agreement.
