**RESOLUTION REQUESTING THE HONORABLE MARGIE JUICO, CHAIRMAN,  
PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) TO ESTABLISH A SMALL  
TOWN LOTTERY IN THIS MUNICIPALITY AND TO GRANT THE FRANCHISE IN  
FAVOR OF SASKIA ROYALE CORPORATION**

**WHEREAS**, one of the development thrusts of the new Municipal Administration is to reduce the problem on unemployment to alleviate the social and economic conditions of the people and the operation of Small Town Lottery in the municipality may serve the purpose;

**WHEREAS**, the Sangguniang Bayan of Narvacan, Ilocos Sur considers the operation of Small Town Lottery (STL) in the municipality to generate additional sources of funds at the Municipal Level for economic development purposes;

**WHEREAS**, the operation of STL shall eventually eradicate "jueteng" and other unlawful number games and shall also provide alternative sources of income of our constituents who are obsessed with the said illegal number games and those who are working as *kubrador*;

**WHEREAS**, in connection to this, the Sangguniang Bayan of Narvacan, Ilocos Sur received a letter from Saskia Royale Corporation requesting the August Body to enact a Resolution addressed to the Philippine Charity Sweepstakes Office to authorize the establishment of Small Town Lottery (STL) in the municipality and for the PCSO to grant a franchise for the said form to operate STL;


**RESOLVED FINALLY**, to furnish also a copy of this Resolution to **Saskia Royale Corporation** for its information and appropriate action.
